

# Fall-Winter 2018-2019 Union County Youth Hockey League U10 Development Hockey Program

This program is intended to be an entry point to competitive play for beginner players age 9-11 – born in 2007 through 2009. The emphasis of the program will be on skill development in accordance with the USA Hockey ADM (American Development Model).

A combination of skills will be taught during the practice sessions including skating technique, stick and puck handling, power skating and shooting skills. Many of the skill drills are structured as fun games for the players, providing an environment proven to be conducive to learning. Short scrimmages may be conducted after practices to reinforce skills learned during the previous instructional period.

## Coach Information:

- Matt Anderson is the Director of Hockey and Player Development for this program. He and JJ Hoeffler will provide professional instruction at most practice sessions.

## Program Features:

- Approximately 48 practice/game sessions.
- Union County Youth Hockey League jersey.
- Teams are formed as needed on the day of the scrimmage sessions.
- October games will be played on Small Ice, using our new Training Pond to make the game play tighter and accelerate development.
- Goalies typically remain in their position for the Full Season, however we do have trial opportunities for interested players.
- End of Season tournament at Union Sports Arena for the Development Program will occur on a date and time TBA

## Please Note:

- This program is intended for relatively inexperienced players age 8-11 (birth years 2007 through 2010). 2007 players will only be accepted subject to their prior experience skill level.
- Full equipment is required for all USA Hockey programs.

- Fee will be pro-rated for players joining mid-season.
